1 Introduction

Welcome to the first Newsletter we've published since June 2013 when the campaign went into a comparatively "quiet" period. That all changed recently, as you will find out from reading this edition.

We close another year with a degree of uncertainty about the future of the open spaces in Ringwood Forest & Moors Valley Country Park. We remain determined, however, that with your invaluable help & continuing support we shall continue do everything possible to make sure that the right decisions are made.

And so as we look ahead to the challenges a New Year will bring us, we sincerely hope that you and those you care about will enjoy a very happy and peaceful festive season.

2 Hampshire Minerals Plan & Purple Haze (North)

It was with a sense of sad inevitability that despite your hard work and our in-depth submissions on the many problems to be faced by an operator, in September 2013 the Hampshire Authorities adopted their Minerals & Waste Plan and included Purple Haze (North).

The current position is that the lease for both Purple Haze (Hampshire) & Purple Haze South (Dorset) is still for sale and no operator has been appointed. Until an operator is in place, the planning application process cannot begin and with it the necessary and detailed public exploration of what's required to resolve the many uncertainties identified in the Planning

Inspector's Report.

We have secured assurance from Hampshire that FoRF and Verwood Town Council, amongst others, will be notified about any planning applications submitted for Ringwood Forest. Hampshire also said they will tell us when they become aware of the minerals company likely to submit a planning application for Purple Haze.

Be assured that lobbying against Hampshire's plans continues at every opportunity, However, until a planning application process begins, ramping up the public campaign is considered unlikely to change either the landowner's or Hampshire's intentions. Given feedback from supporters, that opinion appears to be widely held.

We're not infallible, however, and are always willing to re-think campaign tactics. Please let us know at info@forf.org.uk if you think we should be doing something else right now and also the activities you would be willing to commit to. If there is sufficient committed support, we will plan accordingly.

3 Dorset's Minerals Plan & Purple Haze (South)

In a recent message to FoRF supporters, and on the campaign's Facebook page @ <https://www.facebook.com/pages/No-2-Purple-Haze/144871228914877?fref=ts>, we advised that Somerley Estate had offered Purple Haze (South)* to Dorset County Council for minerals extraction (building sand) and subsequent restoration. No mention has yet been made of using the site for landfill.

** Purple Haze (South) begins close to the car park area near Bakers Hanging (the Alderholt turn-off), avoiding all but a very small corner of Watchmoor Wood, and then extends in the direction of Verwood along the B3081 to abut the Hampshire allocated site.*

The first step in **Dorset's public consultation on the sites to be considered for their Minerals Plan**, including all sites offered to them together with those previously withdrawn, **will run from 19th December 2013 until 13th February 2014**. The consultation process is forecast to progress until at least the middle of 2015 and possibly beyond.



Public consultation events on Dorset's Minerals Sites will be held, exhibition style, throughout the county including in **Verwood Memorial Hall on Thursday, 16th January 2014 from 3:00 pm until 7:00 pm.** Dorset's aim is to gather local community views on the sites to be considered. We are told the sites are not being promoted at this stage.

We encourage everyone who is able to attend these events to do so. It's important that those awkward questions about any of the sites are asked as soon as possible.

Nearer to the event we'll share our list of questions. For example - for Purple Haze (South) we might query the quality & location of the minerals which lie on the same geology as Blue Haze. We know that very little of the soft sand extracted was sold to industry due to its poor quality for building with the bulk being used as back fill at Roeshot . . . and so on.

On the Verwood Town Council Facebook page @ <https://www.facebook.com/pages/Verwood-Town-Council/160929110732685?fref=ts> you will find a posting about the Verwood event which includes this summary -

"Bournemouth, Dorset and Poole councils are considering potential new locations for future mineral extraction, to be included within a document called the Mineral Sites Plan. Once adopted, this plan will identify specific sites for mineral extraction within the county. We would like to hear your views on 44 sites that have been suggested by mineral companies, landowners and consultants."

Other channels for public comments will be available. We expect Dorset to provide details when they launch the consultation on 19th December 2013 with local press releases to follow in January 2014.

£21.00 was claimed for unavoidable child care expenses. The remaining balance (£464.84) represents initial personal outlay for campaign related materials (stickers, T shirts, paper, printing, etc.) which could not be reimbursed until after sufficient public donations had been made to campaign funds.
